Actions: Use 'strong recommendation' to take Computer Apps first Create a pre-assessment to determine student readiness
Perkins Consortium Membership	 Notes: Do not have to be a member of a consortium 16 charter schools with approved programs/4 are members of a consortium (including BlueSky) Can still meet <u>SBE Guidance For Schools</u> There are concerns with how the consortium has been approving requests. Do we want to get into another consortium? Potentially we are looking at a request for \$15K next year It may not be worth the money if we are only getting \$3-5K They have asked us to use the CTE label from classes that are not on the approved program list. Is there a benefit for our school besides the money? They tend to focus more on Dakota County It doesn't seem to give us a marketing advantage with being in it Trend is moving towards college in the classroom type lessons Where are we allocating our time and resources? Is this the avenue that we want to invest in or are there other bigger picture options that may be more effective? AP classes, dual enrollment Parent survey ~ we have seen some interested in higher level (5-10 responses) Would we get enough enrollment and maintain that for AP Could we survey PSEO students to see if they would prefer AP or CIS rather than PSEO? Course options might open the door for interesting topics (i.e. intro to education)

	BlueSky's Local Literacy Plan	 Notes: There will be an instructional training. The training is 120 hours (3 full work weeks) which will take place over the year We need to select curriculum and intervention materials aligned to the science of reading We may need to go back and re-work some of our curriculum (specifically reading elements) to meet expectations There will be training that goes with the instructional tools that are approved by MDE There will end up being a cutoff that is students fall under certain identifications for screening, they would need to have an intervention Draft of this Literacy Plan will be sent to the school board for approval next How will staff have time, motivation, and resources to complete the training? Plan is due in June, going to May board meeting for approval Actions: Committee was in favor of presenting the plan to the school board
